This year's show will not be juried. This means your paid entry(ies) is guaranteed a place on our walls.

Cash awards for Best of Show, and four Merit awards (award amounts contingent upon the number of entries received).

Eligibility and Requirements

- Open to female artists 18 or older everywhere. All visual media except film, video, installation, and performance accepted.
- Works not previously shown at the Chico Art Center gallery or gift shop will be accepted.
- Entry fees are non-refundable. **CAC Members: \$15 per entry, Non-Members: \$20 per entry. Limit two entries.**
- **Shipped works must arrive on or before the drop-off date.** Shipped entries must add a \$10.00 handling/repacking fee.
- Works can be for sale or not for sale (NFS). A 30% commission donation is requested for sales resulting from this exhibition.
- Work must not exceed 30" in any direction, including frame. Sculpture height is limited to 8 feet. **No exceptions.**
- Hanging work must use securely attached eye hooks and braided wire. Please, NO sawtooth hangers.
- 3D works must be able to be moved by one person.
- Necklaces, earrings and other jewelry must be presented as a set at one price. No individual prices for separate items.
- Work determined by the gallery director to be too fragile for safe handling and/or display will not be accepted.
- All work submitted must be completely dry.
- No title or price changes after time of drop-off. No artwork may be removed prior to the close of the exhibition.
- A signed entry form (below) must accompany artwork and is required.
- **Works not meeting these requirements may be withheld from this show.**
- **Works not picked up June 12, by 6 PM will be charged a \$5 storage and handling fee. After 30 days, the fee will be \$35. After 90 days it will be considered abandoned and become property of CAC.**
- **Illegible entry form may result in misspellings, or the inability for us to contact you if needed-please print clearly.**
